PCR/FRRS 2016 Convention, Taking it To The Streets 2016

We are partnering our PCR convention as a joint convention with the Feather River Rail Society's annual convention. Because we have different agendas we will hold separate banquets, but will have otherwise shared activities. Our partnership with FRRS will increase the subjects and choices of activities available, in both clinic subjects and outside events. Because of our joint convention, NMRA membership is not required to register. But only NMRA members may enter models, photos and crafts for NMRA judging and awards. FRRS members may share their models and photos as display only. A 6-month Rail Pass is available to encourage participation and have a 'look-see' without a long-term commitment. Also available are full NMRA memberships with or without the NMRA magazine and student memberships that include NMRA magazine. All levels of NMRA memberships may be requested and paid for on the registration forms.

Registration

The Early Bird Special Registration Package fare of \$89 includes registration, awards banquet, and PCR breakfast. (The Early Bird Package deal ends Jan 31, 2016. There is no fare differential between rail and non-rail registrations; however, non-rail includes the non-rail lunch, not the PCR breakfast.

The special "First Timer" fare of \$79.00 is available for PCR members that have not registered for the past 5 conventions. The "First Timer" special also includes the awards banquet and PCR breakfast.

Awards banquet only attendance is \$45.00.

President's Report

My upbeat perspective got a boost from the recent quarterly get together of my home Division, the RED. I counted

twenty-seven names on the signup sheet (the usual is around twenty) and we were all treated to a great program, capped by a riveting clinic on 3D printing given by Andy Cohen of E-Stuff Plus. My compliments to the

great work by Program Chair Dave Grundman,
Superintendent Peter Barnes,
Chief Clerk and Paymaster
Ed Zakareckis, and, for the as
usual spectacular show and
tell, Contest Chair Guiseppe
Aymar.This leads me into the
topic of enthusiasm,
participation, and the future
of NMRA.

With regards to enthusiasm, I think we're in.

Participation is a mixed bag. Like for many nonprofit hobby organizations, it's always a challenge for us to find members interested in filling essential roles in our organization that are necessary for these activities

we like to attend to take place. As a result, we have "elections" that rarely feature more than one candidate, and maybe 10% of us bother to vote. This may sound like nagging, but it is fact as well.

As a result, the same small core of folks tend to rotate through all the available positions, sometimes coming back for a second run at them. What you lose out on is the injection of fresh perspectives and, to raise a familiar issue again, younger faces to carry the flag into the future. We're talking about long term strategic planning here.

So what's to do about this?

Well, your elected representatives on the PCR Board, the Division Directors, pointed out what they considered an unfortunate situation that may be a small but important part of the picture. Division Superintendents, they all agreed, do a lot more work than Directors but get less credit and recognition. Directors qualify for AP credits as NMRA officials, but Superintendents don't because their positions are considered Division creations and not part of the NMRA proper. They would have to be voting members of the Regional Board to qualify.

Of course, they could qualify for AP credit as volunteers, but come on now. Aren't we all volunteers? Without their efforts, much of what we do together as

NMRA members wouldn't happen.

At the Board's urging, I did some investigation. I sent queries to all the other Regional Presidents to find out how things were set up in their Regions and how they handled this system. I also pulled up all their websites looking for information as well. I received replies from ten Regional Presidents fairly quickly, most of them very eager to be of help. What I found out was surprising and informative.

First of all, I discovered that PCR's governance structure is not the norm. Far more commonly, the District Superintendents are also voting members of the Regional Board. In at least two cases, they essentially served as the Directors as well. Apart from PCR and PSR, the issue was a moot

NMRA does not go down and stop at the Region but in fact starts at the Division and travels up. one. Some of these Boards, by the way, must be enormous.

Nonetheless, I for one feel that the message is not the right one, that NMRA does not go down and stop at the Region but in fact starts at the Division and travels up. The Division is the only NMRA most members ever experience and it is the NMRA that attracts and retains new members. It's where the frequently heralded "fellowship" takes place.

Your Board is not alone on this issue. As it turns out there are people at the National level who share our point of view enough to be exploring the possibility of changing the current rules. It may in fact happen, but would take some time. As the "Dude" once said in "The Big Lebowski" - "There's a lot of ifs, ands, or buts here." Meanwhile, we might think about some alternatives that PCR could initiate on its own. For instance, we could change our bylaws so that Superintendents were voting members of the PCR Regional Board.

If we did that the board would be bigger by four members. Is that a problem? Is it redundant having the Superintendent and Director from each Division both on the Board? Do we need both? One advantage to combining the two offices would be reducing the number of willing candidates for office we have to scrounge around for by four.



Achievement Program - Model Railroad Engineer - Electrical (Part 1)

Continuing our discussion on various AP certificates, this month we will talk about the requirements for Model Railroad Engineer - Electrical. Like the other certificates, the full requirements for this category are available on the Internet at the NMRA website.

The essence of this AP certificate is to demonstrate knowledge of

wiring a model railroad. The required work can be done on your own layout, a club layout, or even some on a friend's layout.

I will talk about the first two requirements this month and the rest of the requirements in

the next issue of the *Branch Line*.

The essence of this AP certificate is to demonstrate knowledge of wiring a model railroad.

The first requirement is that you construct and demonstrate the satisfactory operation of an electrical control system on a model railroad capable of simultaneous and independent control of two mainline trains in either direction and containing at least a) five electrical blocks if running DC or, for DCC, sufficient gaps and switches to maintain polarity, phase if needed, and troubleshooting; and b) one mainline passing siding; and c) one reversing

loop, wye, or turntable; and d) one yard with a minimum of three tracks and a switching lead independent of the mainline; and e) facilities for the storing of at least two unused motive power units; and f) one power supply with protective devices. Note that you do not need to build a power supply as long as it includes the required protective device. While this might seem like a long list, note that even a small DCC layout could qualify if there is a way to turn motive power and it includes a small yard, a passing track, and circuit breakers.

The next requirement is that you wire and demonstrate the electrical operation of at least three of the following items: turnout, crossing, crossover, double crossover, slip switch, gauge separation turnout, double gauge separation turnout, three-way turnout, gauntlet turnout, spring switch, or an operating switch in an overhead wire. You do not need to scratchbuild any of these track components, just show that you can make them work electrically. For example, wiring up the simplest powered turnout from the hobby shop will satisfy one of the three required electrical track components. Likewise, most

commercial crossings come pre-wired. All you need to do it set one up so that you can run trains through both tracks. The whole point of these requirements is for you to demonstrate a variety of skills and understand the need for track gaps, etc. The guidelines continually stress to not read more into the requirements than need be or make them harder than they have to be.

I'll talk about the rest of the requirements in the next issue.

Once you complete these requirements, submit a Statement of Qualifications (SOO) which includes the required drawings and forms. Witnesses must sign a Certificate of Operation verifying that the required items are operational and meet all applicable NMRA standards. Send the completed SOQ to your Divisional AP representative, along with a photocopy of your NMRA membership card and you are on your way toward another certificate!

Mike Blumensaadt was awarded an AP Certificate for Master Builder - Prototype Models. You may have seen his N scale Civil War scene at the 2015 PCR Convention or in the September 2015 issue of **Model Railroader** magazine. Great work Mike!

Richard Brennan recorded 210 Tus for Association Volunteer! His work included over six years as Branch Line editor which alone was worth 184 TUs!

February 21 at the Elks club in Alameda. Great location.




Peter Barnes is in the process of constructing an



Tales of the Santa Cruz Northern -An Ops Weekend

Back in November I attended a regional ops weekend – one of a growing number around the country. The event, Great Lakes Getaway, is similar to the BayRails ops weekend we put every other year here in the Bay Area. It is invitational and for the most part the attendees are from out of the region. Maybe half the ops weekends today have a similar focus. The other half are 'open' and filled on a first come, first served basis and are often local in scope. In general you operate on three layouts over a three day period and have one or several other activities as well.

As is usually the case, there were more layouts I wanted to operate on at GLG than there were days to operate. I consoled myself that I was assigned to my top choices, certain in the knowledge that there were no lemons in the list.

One of the high points of this sort of weekend is the chance to visit friends you don't get to see often and to meet new, like-minded folk as well. Dinners after sessions, time with various folk driving to and from sessions, bull sessions - each add a special flavor. When

we can, a casual group of Bay Area operators will travel together to / from a weekend – more fellowship. Sometimes we end up at different layouts throughout the weekend. This time we had all asked for and been assigned to pretty much the same layouts. The usual suspects this time included Bill Kaufman, Seth Neumann and Bryn Ekroot.

But what about the layouts you say? Well, we certainly had a wide variety in the railroads we operated on. Colorado narrow gauge, Milwaukee Road in the last days under wire, Pennsy 4 track mainline, and the GN through the Cascades – more electrified track! Each presented me and the other boomer crewmembers with new challenges.

Doug Tagsolds is modeling the Colorado & Southern Narrow Gauge from Golden to Central and Silver Plume in the 1930's – in 1/72 scale. He is using HO gauge

track and Roundhouse 2-8-0 engines, which he has modified to 'scale up' in size. MDC 36' house cars fitted with new details and kitbashed passenger equipment all have the proper narrow gauge look. Doug has only been building the layout for about 1-1/2 years since he tore down his Toledo Terminal RR. So while all the track is in and operating on this large basement railroad, only small parts of the layout are scenicked. It didn't matter. Doug does great work and we all had a great time.

Bruce Carpenter's Milwaukee Road currently centers around the crew change point Avery, Idaho. This was also one of the ends of the Milwaukee's electrification. Over the last 4 years Bruce has built his MILW Road West on a third level above his double deck BNSF 'Chili Sub'. So the layout was at or above eye level, even for my 6'3".

Bruce is a Chief Dispatcher for CSX in real life. His Chili Sub is a high traffic density, high speed, fast paced experience. Bruce has built his MILW with a totally different crew experience in mind – giving his operators a taste of what real railroading is like. In 1973 the Pacific extension of

Each of the railroads I operated on ran well and gave me new experiences and offered new insights.

the MILW was on its last legs. The juice to the wire was about to be cut off; the railroad itself would die several years later. Trains are few, slow, and late. Crews die on the law and dog-catching them requires a trip of one to 2 (fast) hours in the crew van - or maybe being deadheaded on an opposing train. The dispatcher is responsible for making sure crews get required rest and keeping track of motive power usage. It takes 1 (fast) minute per car to pump up the train line before you can make a brake test and depart your terminal; 20 minutes per locomotive to service and refuel diesel road power in Avery. This was a very different experience to say the least. It was certainly enjoyable, as long as you were willing to 'play the game'.

On the other hand -Bill Neale models the Pennsylvania Railroad's 3 and 4 track Panhandle subdivision on 3 and 4 decks (two visible, two for staging) in HO. Traffic control is handled by two tower operators each controlling two towers. We moved

somewhere between 30 and 40 trains during the operating session – I truthfully lost count. Bill and I swapped off working one of the tower iobs half way through the session. So I spent half my time running a local with an H10 2-8-0 and pulling a steel drag with an I1sa 2-10-0 'Hippo', with another Hippo pushing. And spent the other half of the session lining multiple trains across multiple sets of crossovers at the two towers, passing train movement information back and forth with Seth who was the other tower operator. Bill's layout was wonderfully detailed. It was again a very different experience for me – the SCN has nothing even faintly resembling the type of traffic control or the sheer number of train movements!

Scott Kramer's Great Northern is a model of the GN over the Cascades. Scott was a helper on Bill Neale's layout and we went over to Scott's after the session at Bill's. Scott has been building the layout for over a decade, but has only relatively recently become interested in operations. When we descended into the basement Bill said that while the GN was supposed to be run on time table and train orders, and had ABS signaling to protect the trains, he had never actually run the railroad using TT&TO. We grinned.

Seth volunteered to dispatch. I worked part time as his train order operator, copying and delivering orders and clearances as needed. I ran the Empire Builder and the Western Star passenger trains in between times. Bryn took over the major yard while Bill handled a number of freights. As we went through the session, we kept giving Scott more and more suggestions for things he could consider to improve his operations – and Scott actually wrote them down! It was really enjoyable for all of us to be in a position to help 'give back' to someone who had opened their home to us and who so clearly wanting to improve how he was making his railroad come to life.

Looking back on the weekend, I think it was both typical and exceptional. Typical in that it was like most other operating weekends, offering attendees a concentrated dose of operations on a variety of different railroads with different traffic control schemes. It was also typical in that a group of people with similar interests all got together to enjoy a mutual fascination. Great Lakes Getaway was, for me, exceptional as well. Each of the railroads I operated on ran well and gave me new experiences and offered new insights. I had good times with good friends and met several folks who I am sure will become good friends in the future.

So if you have the inclination and get the chance I would encourage you to attend an ops weekend. You won't regret it!

Honors Committee Chairperson Ray deBlieck presented a comprehensive list of all PCR honor recipients, dating back to 1957.


Vice President Carol Alexander provided graphics of a proposed new PCR logo. Work continues.

Congress Passes PTC Bill

By Bill Stephens - October 28, 2015 WASHINGTON — Congress today passed a three-year extension of the positive train control deadline, preventing an unprecedented shutdown of the nation's rail network that had railroads, transit agencies, and shippers nervous as the end of the year approaches.

The Senate today approved a stopgap surface transportation bill that funds highway and transit programs through Nov. 20. The bill, approved in the House yesterday, also includes the three-year PTC deadline extension that railroads, transit agencies, and shippers had sought.

House Transportation & Infrastructure Committee Chairman Bill Shuster, R-Pa., inserted the PTC extension onto the Surface Transportation Extension Act of 2015. The bill ensures that states will be able to continue to fund highway and transit projects while Congress irons out the details of a multi-year surface transportation bill.

Shuster said the bill, "also recognizes that failing to extend the positive train control deadline now will have devastating impacts." The rail industry has said it would have to curtail certain chemical shipments beginning in November and would have to virtually shut down beginning Jan. 1 in order to comply with the PTC law.

The Association of American

Railroads welcomed the news.

"This provides the certainty American industries and businesses need to serve the millions of Americans who rely on rail every day," said Edward R. Hamberger, the AAR's president and CEO.

The deadline extension would give the railroads until Dec. 31, 2018 to have PTC installed on lines where it is required. The transportation secretary would be able to grant railroads who fail to meet the deadline up to two additional years to comply with the law. The bill almost certainly will receive President Obama's signature when it reaches his desk.

"This news can finally put all of our minds at ease, knowing that Metra's trains will continue operating in January," Don Orseno, executive director and CEO of the Chicagoarea commuter rail system, wrote in a customer update. "As always, we remain committed to implementing PTC as quickly and safely as we can."

The American Chemistry Council, which had filed a lawsuit in federal court to stop the railroads' planned service embargo on certain toxic chemicals, praised Congress. "We commend leadership in the House and Senate along with their staffs for recognizing the urgent need to address the PTC issue and working in a strong bipartisan and bicameral manner that is all too rare these days," the trade group said in a statement.


